From 1966 to 1969, Mr. Greenwald served as a trial attorney in the United States Department of Justice. Since joining Gordon, Feinblatt in 1969, Mr. Greenwald has served as lead counsel in a broad spectrum of cases. Many of them have involved issues of first impression and significant constitutional litigation. He has argued before the Supreme Court of the United States.

Mr. Greenwald has litigated in the areas of real estate, contracts, corporations and partnerships, and torts such as fraud and misrepresentation. He has handled more specialized litigation in the areas of employment, construction, banking, environmental, antitrust, securities and health care law. He also has handled cases involving medical, legal and accounting malpractice, and has defended clients in criminal cases, including Medicaid and mail fraud, arson, vehicular manslaughter and assault on a federal officer.

Most recently, Mr. Greenwald has served as national trial and appellate counsel defending a firearms manufacturer in nationwide litigation brought by New York State and various municipalities and individuals. He also has served as lead counsel in multi-state litigation defending a Roman Catholic order of priests in child abuse cases. He also has served as a mediator and arbitrator in a variety of cases.
